SECTION IV HEALTH INFORMATION

EYE CONTACT: This product may cause slight eye irritation. Corneal injury is unlikely.

SKIN CONTACT: Exposure may cause mild skin irritation. Prolonged or repeated contact may cause redness, drying, burning, and cracking of the skin. SECTION VI FIRE AND EXPLOSION HAZARDS

STABILITY: Stable
